

## Doggie Day Kamp Agreement



I, \_\_\_\_\_, attest that my dog(s):

\_\_\_\_\_ is/are in good health, have not been ill with any communicable disease or parasites in the last month and have not harmed or shown aggressive behavior towards any person or any other dog. My dog(s) is/are very dog friendly. My dog(s) are spayed/neutered (if over 4 months of age) and current on all required vaccines. I have read, understand and agree to the following:

1. I understand that **Bark Avenue Resort & Kamp (BARK)** is operated by **Mission Animal & Bird Hospital (MABH)** and is an open-play environment. Even when being monitored, there are inherent risks to this type of group play environment. This risks include:
  - a. Transfer of contagious diseases, such as:
    - i. Tracheobronchitis (Kennel Cough) – there are over 100 strains of Kennel Cough, all are air-bourne and almost none are preventable
    - ii. Parasites, such as intestinal worms and external parasites such as fleas and mite.
    - iii. Canine Papilloma Virus
  - b. Injuries such as broken nails, sore pads, abrasions and cuts, puncture wounds (particularly in the shorter coat breeds) and sprains and other injuries due to normal behavior inherent to dogs in a group environment such as running, jumping, wrestling, and mouthing. Dogs are pack animals and assertion of dominance is common and can result in injuries.
  - c. Behavioral problems
2. If health or behavioral problems develop with my dog(s), I authorize all treatments, as deemed best by the staff of **BARK** and **MABH** and I assume full financial responsibility for all expenses involved.
3. The **BARK** staff will evaluate each dog to determine his/her ability to participate in Doggie Day Kamp and will use its discretion to determine if it is necessary for a dog to be removed from Kamp for misbehaving.
4. **BARK, MABH** and their staff will not be liable for any health or behavioral problems that develop in my dog(s) and I hereby release them of any liability of any kind arising from dog(s) attendance and participation at **BARK**.
5. Photographs or other graphic, sound and other image, likeness, recording, etc. may be made of my dog by **BARK** and that such may be used for any purpose without compensation, and I release to **BARK** all rights that I may possess or claim to such image, likeness, etc.
6. Payment is expected when services are rendered. An unpaid charges will incur an interest rate of 1.5% per month. If **MABH** pursues collection proceedings, I will pay attorney fees and costs of collections
7. I have received, read, understand and agree to the terms outlined in the **BARK** document entitled “Boarding Information”, which are made part of this agreement and I understand and agree to all terms of this agreement, including the following:

**Hours of operation of Doggie Day Kamp:** Monday – Friday 7am – 6pm; Saturday & Sunday 8am – 3pm.

(This does not mean that dogs will be in Kamp that full period of time – these are hours available for drop off and pick up. Time spent in the group environment will be based on the best interest of the pets).

**Unless previous arrangements are made, we impose a \$10 late fee for dogs picked up after 6pm on weekdays and 3pm on weekends. If your dog is not picked up by 7pm on weekdays and 4pm on weekends, we will assume that your dog is boarding and will impose a \$28 over night charge.**
